Key Issues to Address

- A. Adoption: Assessment, Planning, Selection
- B. Utilization: Implementation, Effective Use
- C. Exchange: Readiness, Interoperability

Common Needs of extended Care

- Reducing the movement of patient from care area to ambulatory and acute care facilities
 - Reduce cost of health care
 - Increase quality of Care
 - Creatively resolve care issues

Transporting patients is costly

- Transportation Issues- quality and cost
- · Patient security issues
 - Dementia in the elderly patient
 - Damage to health care devices
 - Accidents (transport, patient equipment, and directly to patient)
 - In the case of patients that are high risk from jails and prisons, cost for security personnel is expensive
